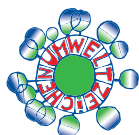

Application and dosage



Daily routine cleaning - WCs, urinals:
neat

Sanitary ware surfaces:
20 - 50 ml / 10 l water



Daily routine cleaning:
50 ml / 10 l water



Foam spray cleaning:
50 ml / 600 ml water

Note

Always use cold water. Rinse afterwards with clean water! The correct dosage saves money and protects the environment.

Pre-wet surfaces with cold water before applying Planta[®] San P 312.

Do not mix with other cleaning agents.

Do not use on lime-bonded natural stone, such as marble, Solnhofen tiles, travertine and shell limestone. Do not use on aluminium, varnished surfaces and acrylic glass.
